BY-LAW NO. C-37

**BY-LAW AUTHORIZING THE CITY OF DIEPPE
TO PERMANENTLY CLOSE A PORTION OF CHAMPLAIN
STREET AND COLLÈGE STREET**

BE IT ENACTED by the Municipal Council of the City of Dieppe :

WHEREAS Section 10(1)p(ii) of the *Local Governance Act*, Chapter 18 of the Statutes of New Brunswick, 2017, authorizes the City Council to make by-laws for municipal purposes respecting the temporary and permanent opening and closing of roads, streets and highways;

AND WHEREAS the closing of a portion of Champlain Street and Collège Street identified in Schedule A hereto attached aims to foster the economic well-being of its community;

NOW THEREFORE BE IT RESOLVED that from the date of ordaining and passing of this by-law, the portions of public street herein mentioned and specified in Schedule A be permanently closed.
